September is National Preparedness Month

This year marks the ten year anniversary of the 9/11 terrorist attacks so it is fitting that the theme for this year's National Preparedness Month is *2011: A Time to Remember, A Time to Prepare*. As citizens are encouraged to prepare for emergencies and disasters, the main focus for this year is on honoring the local first responders that keep communities safe. Although 9/11 is a prominent part of this year's National Preparedness Month's observation, it is important to stress that preparedness is for all hazards, both natural and manmade.

National Preparedness Month is also an opportune time for local volunteer organizations to host events and make the community aware of organizations such as the Kentucky Health Emergency Listing of Professionals for Surge (K HELPS) and Citizen Corps. These organizations are the ones that operate year-round, generally through volunteer programs and trainings in support of emergencies and disaster response. Recent surveys have found that individuals greatly rely on their local communities for assistance in a disaster. They trust

their local first responders, faith-based organizations and neighborhood organizations for receiving assistance and information. Having individuals be aware of the vulnerabilities that exist in their local communities motives them to prepare well in advance of an emergency.

2011 KOIN Workshop Report

The 2011 annual KOIN workshop was held on April 27-28, 2011. The face-to-face workshop was conducted at Berry Hill Mansion in Frankfort and the interactive television (ITV) session workshop was broadcasted from the Kentucky Department for Public Health (DPH) to all local health departments that signed up to participate. The ITV format allowed KOIN members located throughout the state to meet regionally at their local health departments to utilize the ITV technology and reduce the need to travel long distances for the annual meeting. It also allowed them to become better acquainted and form working relationships in the event they need to work together when disasters

strike.

This year's workshop focused on defining and building a resilient KOIN through strengthening KOIN members' capabilities to serve as conduits of information and through exercising the network. A review of findings from the 2010 KOIN Communication and Technology Survey was discussed. Workshop attendees also participated in The Great

Central U.S. ShakeOut earthquake drill on April 28, in addition to discussing the National Level Exercise that occurred May 16-20, 2011.

Workshop participants received a packet of materials, which included a resource CD of various tools and resources to support and enhance KOIN members' capabilities to carry out key functions of the network.

Introducing the Kentucky Functional Needs Collaborative

The Kentucky Functional Needs Collaborate (KFNC) has recently been established to ensure an effective public health emergency response system in Kentucky for populations with functional and access needs.

The role of the collaborate is to develop a long term strategy designed to:

- Serve as a conduit for representing consumers and obtain consumer input and feedback.
- Support the work of the Kentucky Department for the Public Health's Preparedness Branch.
- Advise, consult with and make recommendations for establishing priorities for the Preparedness Branch on matters relating to grant applications, programs, the work of the At-Risk Population Planning Coordinator and implementation of emergency preparedness efforts for populations with functional and access needs.
- Support and assist in the development of statewide partnerships between public health, hospitals and clinic services, businesses, faith-based entities, allied health professionals and populations with functional and access needs.

The KFNC is comprised of subject matter experts and advocates that reflect the diversity of the preparedness stakeholders across Kentucky. The KFNC may include, but not be limited to, representatives from:

- Department for Aging and Independent Living
- A non-governmental/nonprofit agency
- Public Health Agency
- Behavioral Health and Intellectual Disability
- Developmental and Intellectual Disability
- Regional preparedness coordinator, trainer, or epidemiologist
- Kentucky Division of Emergency Management or local EM or representative of local public safety organization
- Education (P-12, post-secondary)
- Faith-based Community
- Homeland Security
- Deaf and Hard of Hearing Agency
- Centers for Accessible Living (Louisville)
- KY Homeless Coalition
- Office for the Blind

Quarterly public meetings will be conducted to provide information to the preparedness stakeholder community and interested general public members. The next meeting will occur on October 26, 2011, at noon at the KCTCS campus (300 N. Main Street, Versailles).
